



**Goal – To promote and enhance the value of the Females of our Bucking Bull Industry**

**Multi- Level (Legacy & Legacy Elite) program that started in 2020 and will be an annual program that will give all size of Breeders/Owners a level playing field to compete and promote their breeding program.**

### **Overview**

- Breeder/Owner will Legacy nominate a designated number of females that are owned by that Breeder/Owner and are in their inventory.
- Nominations will start annually in May for females with calf on their side or fixing to calf in that calendar year.
- Calves (Bulls/Heifers) born to nominated female will compete their Yearling year at the TwoBulls Challenge Legacy Event in Duncan, OK.
- Nominations fees will be \$300 per Female with **100% payback of Nomination Fees.**
- Nomination fees will be split equally between Female/Calves Legacy Bonus Purse for that year's program.
- Yearlings (Bulls or heifers) must compete in TwoBulls Challenge Legacy Event to be eligible for Legacy Bonus Money.
  - Calves can enter Open Yearling class and buck once to compete for Open Purse and Legacy Purse.     **OR**
  - Pay a fee to buck only for Legacy Purse.
- The Legacy Females will be paid Legacy Bonus based on where their Legacy Calf places.
- Legacy Female and Calf Bonus will be paid an equal number of placings and amounts based on # of calves competing for that nomination year.



## Rules

- Any breeding age ABBI Registered Female with a verified dam can be nominated into Legacy Program
- Each nomination is for (1) year, (1) Calf
- Only Females having a **natural born calf** will be allowed in Legacy Program
  - Only Live Cover or AI, natural born to that specific cow
  - No IVF, or Recip bred cows will be allowed.
  - If a cow is flushed, then bred back, then only the natural born calf to that nominated female will be allowed to compete in the Legacy program.
  - If a nominated female has natural born twins, only (1) of the twins will be allowed to compete for Legacy Bonus.
- Once a Female is nominated and paid into the Legacy Program, no refunds or substitutions will be allowed for any reason unless made before nominations close.
  - If calf dies, cripples, or doesn't perform, no substitutions will be allowed.
- Once nominations close for that calendar year, there will be no late entries for any reason.
- A breeder may not enter more than the designated number of females allowed for that calendar year program.
- If Female is in partnership, the female can only be entered under the partner that has the female in his ABBI Registered Inventory, and that female will count toward the nominating Breeder/Owner Legacy count of nominated females allowed.
- Legacy Females can be sold and nomination transferred.
- Legacy calves can transfer ownership prior to competing.
  - Legacy Females and calves will still be enrolled and eligible for Legacy Bonus for that calf so long as calf competes at designated Legacy event.
- Revisions to program may take place as needed, but any changes will be in place prior to nominations for that years Legacy Program.



## **2024 Legacy Program**

- **May 15 – Aug 31, 2023 - Nominations open and close for 2024 Legacy Program.**
- This nomination will be for **Females with natural born Yearling calves** that will compete in 2024 at the TwoBulls Challenge Legacy event.
- Each Breeder/Owner can nominate up to **(5)** Females for the 2024 Legacy Program.
- 2024 Legacy Purse will be paid out in full at the TwoBulls Challenge Legacy Event.

## **Fees**

- Nomination Fees will be as follows:
  - Females nominated between May 15 – June 30 **\$300**
  - Females nominated between July 1 – Aug. 31 **\$400**
  - No Nominations will be accepted after Aug. 31
- There will be an annual Admin fee of **\$50** per breeder
  - Offset Awards, Web Maintenance, and Program Expenses.

## **Phase Two – Legacy Program Side Pot Events starting 2023**

- There will be opportunities for Legacy Nominated Females to continue to generate revenue throughout the competition career of her calves on an event by event basis.
  - Event Producers will have the option to include a Legacy Female Side pot for Legacy females with a Legacy Calf competing.
  - Attached is a schedule of events and producers that have opted to host a Legacy Sidepot in conjunction with their Yearling events in 2023.



## **Phase Three - Legacy Elite Program starting 2024**

- The top **10%** of Females from the Legacy program for that year, will have the option to be nominated into the Legacy Elite Program immediately following the Legacy Program payout each year.
- Nomination Fees for the Legacy Elite Program will be \$500 per Female with **100% Payback of Nomination Fees**
  - If a Legacy Female does not finish in the top 10% due to Calf Performance, Breeder/Owner has the option to nominate into Legacy Elite based on Females previous production performance.
    - Must have produced a natural born calf with ABBI Competition Earnings
  - Nomination Fee for Legacy Female not in top 10% will be \$1000.
- The Legacy Elite Program will follow the Legacy Elite Females Calf's ABBI Competition Career throughout their Yearling year.
- Legacy Elite Champion Female will be based on total money won by Legacy Elite Yearling from Legacy Event through ABBI Finals Yearling Competition.
  - Only ABBI Sanctioned and Co-Sanctioned Yearling Competitions will count towards Legacy Elite Earnings.
- The top **10%** of Legacy Elite Females will split the Legacy Elite Purse at the completion of the ABBI Finals.
- The Legacy Elite Program will only award the Nominated Female, not the calf.

### **Legacy Program Projections**

#### **Legacy 2024**

- (25) Breeder/Owners nominate 5 Females
- 125 Females X \$300 = \$37,500
- Total Payout Purse \$37,500 to be paid out April 2024
  - \$18,750 Legacy Female Bonuses
  - \$18,750 Legacy Yearling Bonuses
